## Hunting / Fishing License

Armed Forces Hunting and Fishing licenses are now available to residents of lowa who served in the armed forces of the United States on federal active duty. The new annual fishing license, or hunting and fishing combo license, is \$5, with a \$2 processing fee. To gualify, veterans will need to submit a

one-lime application for the Iowa Hunting/Fishing License for Resident Armed Forces Veteran along with a copy of their 0D214.

Veterans with a SC Disability Rating can submit their award letter with the application and D0214 to be issued a lifetime license with a one time fee.



## Am | Eligible?

There are 3 things required to qualify for a Service Connected (SC) Disability Rating. They are: Qualifying Service. This is determined by reviewing the veteran's DD 214 for character of service, service dates, awards received, and POW status.

To obtain a copy of your DD 214 please visit the County Recorder in the county you moved to at discharge, contact your County Veterans Affairs office for assistance, contact the IDVA for assistance, or submit an SF 180 to the NPRC.

Diagnosis of a Current and Chronic Condition-This diagnosis from a medical professional for a claimed issue that has persisted for a long time or is constantly recurring.

Nexus & Rationale. This is an in service event, exposure, or previously SC issue that is directly or causally related to the current diagnosed condition being claimed.

To Qualify for a Non-Service Connected or Survivor's Pension the claimant must meet a means test and the veteran must have at least one day of service in the following eras:

\*World War I (April 6, 1917, to November 11, 1918) \*World War II (December 7, 1941, to December 31, 1946)

\*Korean conflict (June 27, 1950, to January 31, 1955) \*Vietnam War era (February 28, 1961, to May 7, 1975 for Veterans who served in the Republic of Vietnam during that period. August 5, 1964, to May 7, 1975, for Veterans who served outside the Republic of Vietnam.) \*Gulf War (August 2, 1990, through a future date set by law or presidential proclamation)

## **Veteran Plate**



Who is Eligible? A resident owner of a vehicle who meets the definition of a veteran according to lowa Code Section 35.1 (2) (c). [See QR Code]
Requirements: A copy of the DD 214 (other than copy 1) that must show the dates of service and character of service at least under honorable conditions. National Guard and Reserve members must have served at least 90 days of active duty service for other than training, or National Guard and/or Reserve minimum of 20 years of service, discharge under honorable conditions, eligible for

#### retired pay at age 60.

Eligible Vehicles: Automobiles, Multipurpose vehicles, Sport Utility Vehicles, Motor Homes, Motorcycles, Trucks, Trailers, & Vans Numbered Plate Fee: One set at no charge, Second or subsequent sets at \$25, Annual Registration Renewal

Fee PLUS \$5 Annual Registration Fee to the Veterans License Fee Fund at the time of renewal. [The \$5 annual validation fee will be credited to the Veterans License Fee Fund.] Personalized Plate Fee: One set at \$25, Second or

subsequent sets at \$50, \$5 Annual Validation Fee to the Veterans License Fee Fund at the time of renewal, [Annual registration renewal fee paid to county treasurer.]

\*Emergency Housing Repairs -\$10,000 lifetime maximum. \*Emergency Vehicle Repairs – \$10,000 lifetime maximum (not exceeding the value of the vehicle). \*Dental - \$10,000 lifetime maximum. \*Audiology - \$1,500.00 per ear within a twelve month period. \*Travel - For wounded veterans directly related to follow-up medical care. Per diem \$50/day up to \$1000. Unemployment Assistance – Due to prolonged physical, mental condition or disability causing their unemployment. \$3,000 in a twelve month period \$6,000 lifetime maximum. \*Job Training or Education Assistance – \$3,000 lifetime maximum. \*Individual or Family Counseling -Up to \$5,000 in a twelve month period. \*Emergency Vehicle Purchase – One time up to \$5,000. \*Emergency Room – \$10,000 lifetime maximum. \*Durable Medical Equipment - \$10,000 lifetime
