 - i. VA is requiring Veterans who use the MyHealtheVet app to upgrade their logon by January 31. On that date, Veterans will need to log on to all VA apps through id.me or login gov Central lowa only has 7,390 Veterans to update
 - ii. Conducted training at the ICVA Fall School, attended by all 99 counties
 - III Traveled with the Virtual Mobile Clinic throughout September and October for 16 visits and assisted 334 Veterans.

- VA Central lowa has permanently housed 167 homeless Veterans, exceeding the goal of 132 Veterans by 26 5%
- VA Central Iowa received a 91.9% trust rating from the Veterans Satisfaction Survey, which is slightly ahead of the National Trust Score of 91.8%
- iv. In June, the Virtual Mobile Clinic was activated that travels three times a week to most rural counties to provide health care.
 - 1. On Fridays, the VMC is deployed to the CRRC downtown to provide primary care services to homeless Veterans.
- v In August, the new CBOC in Marshalltown was opened
- vi. Renovations to the Carroll CBOC were completed
- vii Expansion of the CLC and DOM programs
 - 1. CLC is up to 73 beds with plans to expand to 80 as staff is onboard
 - 2. DOM is fully operational and staffed at 60 beds.

 - a. QRFup is a free mobile crisis response app dedicated to supporting Service Members, Veterans, First Responders and their Families during critical times.
 - b. User downloads the app, pushes the red button and a SOS goes out in three forms: text message, email and phone call
 - Phone call is answered by a therapist licensed in their state. During the call they are triaging the Veteran or First Responder
 - 1 60% of calls are handled by the therapist.
 - ii. GPS locator allows for QRFup to send out crisis team if needed
 - c. Stay with the Veteran throughout their life, contact does not stop after the call
 - d. Launching nationally in May 2025
 - e. Integrated with the VA crisis center. After the crisis event, they will get the Veteran into an appointment in the next day

 - a. As we closed out Calendar Year 2024 I am sharing statistics and demographics of our residents at the Iowa Veterans. Home. Our Admissions Team, led by Kathy Kopsa and Jason Matteson, and involving many other staff throughout the IVH campus, grew our resident census from 385 on January 1, 2024 to 409 on December 29. The last admission for the year was on December 23, 2024, and this Veteran was resident # 19,533 since the facility opened on December 1, 1887. Amazingly, 110 Veterans and spouses moved in and made the Iowa Veterans Home their new residence during calendar year 2024, Sadly, 96 of our residents passed away during 2024, including six during the last week of the year. As we begin 2025, we have 403 residents, including Veterans from the following wars and conflicts, branches of service, and ages:

- b. IDVA Focused on Fulfilling Responsibilities in Iowa Code Chapter 35A. Included in these quarterly meetings of the Iowa Commission of Veterans Affairs are a wide range of stakeholders in the Veterans Community here in Iowa and beyond. We see the U.S. Department of Veterans Affairs, the State Department of Veterans Affairs, County Veteran Service Offices, Veteran Service Organizations, other State Agencies, elected officials, trade associations, non-profits, individual Veterans, and advocates. All of us come together to ensure that Iowa Veterans receive the support, care, and compensation they've earned through service. I hope all of us see what we do as working together to serve Iowa Veterans. I don't work for the Federal VA, but work with them for the benefit of Iowa Veterans. County VSOs do not work for me they work for a County Commission and Board of Supervisors - but we work together to deliver services, benefits and entitlements. The Department is focused on fulfilling our responsibilities outlined in Iowa Code Chapter 35A.
- c Legislative Session Begins! The 91st lowa General Assembly lowa Legislative Session commences on January 13, 2025. Mike Olson, IDVA Legislative Liaison, has worked diligently to ensure that we are prepared Our Department is sponsoring two bills during this session, outlined below is a very brief overview. Mike Olson will provide details.
- d. 2025 IDVA Veterans Trust Fund Modernization Bill. We will ask the Legislature to consider increasing the lowa Veterans Trust Fund principal limit from \$50 million to \$75 million and continuing to make \$500,000 of the lowa Lottery's \$2.5 million transfer available annually until the \$75 million limit is reached in a necessary step to ensure Veteran's claims for assistance can continue to be met
- e **Iowa Department of Veterans Affairs Code Revision Bill.** We will ask the legislature to consider removing the last reference to the last remaining reference to the National Association of Veterans Service Officers in Iowa Code, found in 35B.6(1)c(2) and replace that reference with the Commandant of the Department of Veterans Affairs. This will ensure that the Department able to fulfill its responsibility of validating that County Veteran Service Offices are properly trained and accredited.
- f. Veterans Day on the Hill Veterans Day on the Hill will take place on Wednesday, January 22, 2025, in the Rotunda of the State Capitol. We are looking forward to a great assembly of elected officials, Veterans community stakeholders, Commissioners, Veteran Service Organizations, and County Veteran Service Officers. Karl Lettow and Mike Olson are developing the speakers list and program. Invitations to the Senate and House Veterans Committee will be mailed to the Senators and Representatives on January 9. - Licensed Staffing Process Changes at IVH Effective January 6, 2025 Over the last four months Sarah Bruner and our Nursing Services Directors have been developing a change to the policy used to ensure that we have adequate staffing available to support the needs of residents at the lowa Veterans Home. This policy was implemented on Monday and we will be carefully adjusting as we proceed This policy is the result of listening to our licensed staff, the frustrations that go along with mandated overtime, and suggestions on how we can do better. We listened, we are being responsive, and we will continue to do so I sent out the details of this policy change to Commissioners. Please let me know if you have any issues or concerns
- h Mental Health Conference at IVH May 1-2, 2025 Dr. Doug Steenblock, Mental Health Services Bureau Chief at the lowa Veterans Home, is coordinating with other mental health specialists in Iowa and the Midwest to facilitate a Mental Health Conference on May 1-2, 2025 at Whitehill Auditorium. As America ages there will be a greater demand to address the mental health needs of seniors, especially those who reside in long-term care facilities. This conference will provide additional support to clinicians and administrators who work with this population. Day 1 will include an onsite half-day workshop focused on non-pharmacologic management of dementia-related behaviors. Day 2 will include a full day of didactic presentations both in-person and virtual covering a range of topics including hoarding in seniors, elderly sexuality, management of personality disorders in long term care, finding meaning and purpose later in life, interventional psychiatry for geriatric patients
